2.7 Information Collected

i) Cookies

- for security purposes.

Most of the GFH website operates by using this type of cookie. If you wish to make full use of the GFH website, it is required that you accept cookies.

ii) How we handle email

We will preserve the content of any email that you send us if we believe that we have a legal requirement to do so. Your email message content may be monitored by our GFH employees for security issues including where e-mail abuse is suspected; our response to you may be monitored for quality assurance issues.

iii) Credit card payment and security

Subscription fees and other charges are completed by credit / debit card. Your credit card payments are processed by the “Stripe” payment gateway, which is a secure payment facility and supports all major banks. GFH does not see or store or record your credit card details.
